- Must have performed outstanding service for the betterment of the community.
- Has made exceptional and sustained contributions to the community.
- Must possess characteristics including honesty, sincerity, integrity, and benevolence.

Non Profit of the Year Award

- Must be an active 501-C(3) or 501-C(6) organization.
- Must have a record of longevity and stability.
- Must demonstrate community consciousness with civic/community involvement
